Brief Description of Assignment	1) This research seeks to examine the prevention of environmental crime and wildlife trafficking, with particular emphasis on the scope and effectiveness of existing legal frameworks and the role of the police in enforcement. It will critically analyse relevant laws, institutional arrangements, and policing practices to identify gaps, limitations, and operational challenges. The study will further explore issues related to investigation, prosecution, and inter-agency coordination in addressing such offences. The primary objective is to develop evidence-based recommendations aimed at strengthening legal responses, enhancing police capacity, and improving the overall effectiveness of enforcement strategies to combat environmental crime and wildlife trafficking. 2) This research proposal investigates the relationship between police accountability and public trust in the context of the July 2024 Revolution. It aims to examine how the revolution has influenced police practices, transparency, and accountability mechanisms, as well as shifts in public perceptions and confidence in the Bangladesh Police as an institution. The study will employ a comparative approach, analyzing data and community feedback collected before and after the revolution to identify significant changes and emerging challenges. It will also explore the role of political dynamics, civil society, and the media in shaping police accountability and public trust during this transformative period. The findings are expected to provide valuable insights for policymakers, law enforcement agencies, and civil society organizations seeking to foster a more transparent, accountable, and people-centric policing system in post-revolution Bangladesh.
